#### 1 Respective responsibilities of the body and the auditor

In the completion of the Annual Internal Audit Report, the internal auditor has confirmed that due to restrictions caused by the coronavirus pandemic, full evidence could not be obtained to provide a positive assertion to internal control objective 'G', and no evidence had been reviewed to confirm that period bank reconciliations have been conducted.
